POLICE CHIEF STEVENS TO RETIRE AFTER 26 YEARS

Barre Town Chief of Police Michael Stevens and the town Selectboard have announced Chief Stevens' plans to retire June 30, 2017. Stevens has served as Barre Town's Chief of Police since September, 1990. With more than 26 years as police chief, Stevens has led the department for more than half the years Barre Town has operated a police department. He has served the town more than 30 years, having been hired as a patrol officer in August, 1986.

Selectboard chairman Tom White, who served on several



budget committees before being elected to the Selectboard, praised Stevens for his vision and practicality. White said he has been impressed with the police department's equipment with a budget that is consistent year after year. He mentioned the department's use of body cameras for several years while other communities were still discussing providing the cameras.

Town Manager Carl Rogers has valued the Chief's service, including as a member of the town's management team, saying "Mike Stevens thinks first about the Town's needs and its best interest, not his own interest or the department's."

Seven full-time officers report to Chief Stevens. On the occasion of his retirement, they had this to say: "We at the police department want to wish Chief Stevens well in the next stage of his life. Serving as police chief for 26 years is no small feat. Thank you for your leadership and guidance and for providing a fun and rewarding place to work." Sergeant Dodge, who has worked with Chief Stevens for 20 years, added, "I would like to thank Chief Stevens for providing me the opportunity to grow as a supervisor, and learn the administrative and leadership side of policing."

Chief Stevens has served in several other capacities as well. He represents Vermont law enforcement on the State Emergency Response Commission, and is currently chair of the Local Emergency Planning Committee for Washington County. In the past he served as President of Barre Kiwanis Club, and was a Director on the Board of Washington County Youth Service Bureau for 20 years. He is a member of the American Legion.

The next Chief will have some big shoes to fill. In January, the Selectboard began discussions, consultations, and planning for recruiting and selecting the next chief. Stevens will assist with the recruitment and selection, as needed. The goal is to hire the next chief before July 1 to facilitate a smooth transition.

ANNUAL DOG LICENSE(S) ARE DUE



Do you own a dog? Does the dog live in Barre Town? If you answered yes to both questions then by Vermont law (20 VSA Sections 3541-3591, 3801-3813) your pet is required to be **licensed annually** in the

Barre Town.

What do I need to license my pet?

- 1. Have a current rabies certificate on file with the Town Clerk's Office or provide the office with a copy of the certificate a the time you license.
- 2. Pay the license fee (\$10.00 for a spayed or neutered animal and \$14.00 for an animal that is not fixed).

3. Remember the <u>deadline to license your dog(s)</u> is April 1, <u>2017</u>. If your pet is found to be unlicensed after April 1, 2017 you can be fined \$35.00.

If you have a rabies certificate on file with the Town Clerk's Office but it will expire before April 1, 2017, you will receive a postcard reminder to have your dog revaccinated and to file the new rabies certificate with the Clerk's Office.

Dog license renewal forms (for dogs with current rabies certificates) for calendar year 2017 will be in the mail by the end of January. Be sure to check the license information carefully, make corrections if necessary, sign, enclose your payment, and return to the Town Clerk's Office in the detachable envelope.

HAZARD MITIGATION PLAN

Staff, with assistance from the CV Regional Planning Commission, continues to work on the all hazards mitigation plan. All hazards means natural and manmade disasters are considered. A presentation to the Selectboard in early April is being planned. The presentation at a Selectboard meeting gives residents an opportunity to learn about and comment on the plan by attending the meeting, or watching it on CVTV or on the town website.

MARCH TOWN MEETING DAY FAQ

Traditionally, the first Tuesday in March, voters from around the State gather at their respective polling places to

make decisions on local issues. This day has become known as "Town Meeting Day." This year, as is customary for Barre Town, the March election will be for school issues only. Municipal issues will be decided in May.

What's on the School Ballot? Barre Town has two school districts (Barre Town Middle & Elementary School and Spaulding Union High School). However, all questions will be on one ballot. On March 7, 2017, voters will be asked to vote on the standard things such as election of School Directors (one for Spaulding High School and two for the Elementary School), a School District Treasurer, and to approve a stipend payment for these elected officials. Other equally important questions will be the proposed fiscal year 2017-2018 school operating budgets, whether to allow the School board to borrow operating funds, and asking for monies to be put into a capital reserve fund.

Where do we vote? All Barre Town elections are held at the Barre Town Middle & Elementary School gymnasium (70 Websterville Road). Polling hours are 7:00 a.m. – 7:00 p.m. Parking is available in the school lot. Please use the side entrance. If you need assistance getting from the parking lot to the gymnasium, please contact the Town Clerk's office at 479 -9391 prior to election day.

<u>Can't make it to the polls? Request an early ballot.</u> To request an early ballot for this or any election, contact the Town Clerk's Office at 479-9391 or <u>dkelty@barretown.org</u>.

When is the deadline to register to vote? I am very glad you asked – as there is none! On January 1^{st,} a new law went into effect allowing for same day voter registration.

What does same-day voter registration mean for me? Prior to January 1st, if you were not a registered voter in a town and wanted to vote in an upcoming election, you would have been required by law to submit a completed application to the Town Clerk by a certain date. If you missed that deadline, you could not vote in the election unless a judge issued an order directing the Town Clerk to add you to the voter checklist. The same day voter registration law removes the deadline to register to vote, allowing you to come to the polls on election day, complete the checklist application, and vote!

Another big election change is the creation of an online voter page which is hosted by the Vermont Secretary of State. This online "My Voter Page" gives an individual many options for managing your voter rights. From this webpage, you can register to vote, change your voter registration from one town to another, obtain information on state and federal elections, request and find the status of your early ballot request. TOWN CAUCUS MEETING NOTICE

The <u>Barre Town Non-Partisan Caucus</u> meeting will be held on Monday, March 13, 2017 at 6:30 p.m. at the Barre Town Municipal Building.

What is a Non-Partisan Town Caucus? A Town Caucus is a meeting of the members of a political party who get together to select/nominate a candidate for an elected office (Selectboard, Moderator, Town Clerk, etc.). Non-Partisan just means that the political parties hold their meetings together, not separately.

Why does Barre Town hold a Caucus? Many years ago, there were issues in recruiting individuals to run for an elected office. So, to ensure there is at least one candidate for each municipal office, the decision was made to hold a Non-Partisan Town Caucus. While the meeting holds no "official standing" and is not required by law, we continue the tradition today for the same reason.

BARRE TOWN'S ANNUAL MEETING AND ELECTIONS

In accordance with our Town Charter, Barre Town has two (2) municipal elections, an Open Town Meeting and a vote by Australian ballot.

The Open Town Meeting (first Wednesday in May), is a 'from the floor' vote. It will be held on May 3, 2017, in the Municipal Building, Selectboard meeting room, and begins at 7:30 p.m. Articles to be voted on will include: setting the property tax and sewer installment due dates; asking for approval to apply the State tax credits pro-rata (i.e. to deduct the credit amount from the total tax amount, and divide the remaining balance into 4 installments); to seek approval for the Selectboard to buy/sell real estate; and to present the Wendell F. Pelkey Citizenship & Service Award. Immediately following the Open Meeting there will be a presentation/overview of the proposed budget.

The second vote is the Election of Officers and Voting by Australian ballot, which will be held on Tuesday, May 9, 2017 at the Barre Town Middle & Elementary School Gymnasium. Polling hours are 7:00 a.m. – 7:00 p.m.

The items appearing on the ballot include: election of Town Officers (Selectboard members, Auditor, Moderator, and Town Constable); voting on budgets (General Fund/Highway Fund); a Cemetery appropriation; some of the elected officer wages; and numerous not-for-profit agency requests.

STAFF CHANGES

Retirements: Police Chief Stevens' pending departure (see front page) is not the only big change to the 'veteran' staff roster. He comes to us from the State of Vermont Military Department and has operated heavy equipment and done construction for over ten years. We also have a new police officer keeping us safe. Kyle Laughlin started as a patrolman after Thanksgiving last year. He grew up in Williamstown and worked previously in the Orange County Sheriff's Department. Kyle is working towards qualifying for the police academy and becoming a full-time certified officer. He likes meeting with the public so if you see a tall Barre Town Police Officer you haven't seen before, say hi.

The Rec Board is providing three courts and rackets. Wear comfortable clothing and sneakers, and bring a water bottle. No charge to play or learn!



Backyard Composting Workshop - Wednesday, April 5, 6:00 pm - 8:00 pm. Are you interested in composting in your backyard as a cheap and environmentally-friendly way to dispose of your food scraps, but have questions or concerns about what to compost, and if there will be odors or attracting animals? Come to this workshop to learn how to compost right to address these concerns, and more. Cassandra Hemenway, the Outreach Manager at the Central Vermont Solid Waste Management District will talk about easy ways to get started composting, provide troubleshooting help to composting veterans who might have a question or two, and provide information about Vermont's Universal Recycling Law, which bans food scraps from the landfill by 2020.

There will be a demo of how to build easy bins out of affordable materials. Workshop participants will go home with a counter-top food scrap collection pail, a booklet to remind you of what you learned, and a handout explaining what goes in— and stays out of— the compost bin. One lucky participant will win a compost bin!

BUDGET WORK COMMENCES

The last newsletter included a notice that the Select-



board was seeking applications for the Budget Committee. From the applications received, the board appointed Bob Nelson and Norma Malone to the committee. Town Clerk-Treasurer Donna Kelty chose Justin Bolduc for her appointment. Those three filled out the committee by appointing John

Hameline and Gerry Parrott. The Budget Committee, charged with the responsibility of establishing the fiscal year (July 1 to June 30) 2017-2018 budgets, is comprised of the Selectboard and these five citizens.

During its two months of service, the Committee will set the amount of the General Fund and Highway Fund budgets, which will then be presented for voter approval. The Committee will determine the amount of the Sewer Fund, Water Fund, Equipment Fund, Ambulance Fund, Cemetery Fund and Building Fund budgets. These budgets, whether set for voter approval or for the year, affect the property tax rate, sewer fee and water rate for FY 17-18. The Committee decides what facility improvements will be accomplished and what services will be offered.

Their work is a big deal. The public is welcome to observe the meetings, held on Tuesday nights from 6:30 pm to 8:00 pm in the municipal building at 149 Websterville Road. The topic of conversation for each meeting is listed on the Selectboard's meeting agenda for that night. These

agendas are posted at Hannaford, Graniteville General Store, Trow Hill Grocery and on the town website (www.barretown.org).

Residents are encouraged to join the Committee on its tour of town facilities and project sites. (See article on this page.)

Very preliminarily, major changes or topics to be included in the proposed FY 17-18 budgets are:

<u>General Fund</u> - 1) debt service reduced \$25,000 (town forest loan); 2) tennis court repairs (\$24,000); 3) liability and property insurances increasing; 4) fire department's self contained breathing apparatus (\$50,000 - \$60,000).

<u>Highway Fund</u> - 1) stormwater regulation fees kick-in (\$2,400); 2) road paving program \$32,100 greater than current year.

Equipment Fund - Significant revenue and expense account changes due to town no longer servicing school's buses.

Ambulance Fund - Staff's new work schedule (supposed to save money) changing many expense accounts.

Sewer Fund - Payments for vactor purchase (\$50,000 - \$60,000).

<u>Water Fund</u> - Continue building 8" water line from Mill Street to East Cobble Hill Road.

<u>Building Fund</u> - Second half of DPW shop roof (\$42,000). <u>Cemetery Fund</u> - Restoration of Maplewood Cemetery historic fence (\$5,000).

BUDGET TOUR INVITATION

Part of the Budget Committee's process of learning about and evaluating the budget requests is to visit each department's major facilities. The budget tour helps the Committee better understand department op-



erations and budget needs. Transportation for the tour is provided by bus. There are plenty of spare seats on the bus. The public is invited, indeed welcomed, to fully participate in the tour. Citizens' questions and suggestions enhance the value of this education process.

If past practice is followed, the tour will be Saturday, February 18. Participants gather in the municipal building (149 Websterville Road) between 7:30 am - 8:00 am. Morning beverages and snacks are offered to everyone. The tour begins at 8:00 with departments housed in the municipal building. Conversation and questions are encouraged on the ride between stops. The tour finishes between 12:30 - 1:00 pm.

All participants receive a tour booklet, which gives some budget-related history of the town's buildings and describes each department - staffing, operation, recent budgeted projects and acquisitions, and, of course requests for the next fiscal year. Budget facts and figures are listed as are all town facilities (all playgrounds, pump stations, water tanks, bike paths, etc.). The tour also points out projects (road paving, sidewalk construction, utility work).

PROJECT UPDATES

Websterville Fire District Merger: In November, Barre Town voters approved the merger of the town and the Websterville Fire District Number 3 (WFD#3), which supplies water to 124 accounts, maintains 12 hydrants, and operates a water treatment plant. Voters also approved to levy a special assessment against WFD#3 customers to pay for debt related to major projects not benefiting the entire consolidated system. WFD#3 members still need to vote; that is scheduled for February 22nd, 9am-7pm, at their office at 105 Church Hill Rd. If their members also approve the merger, this constitutes a proposed charter change which must be approved by the Vermont Legislature before going into effect.

South Barre Sidewalk Project: The State has declared the right-of-way clear for this project to construct about 300 feet of new sidewalk on the northeast side of Bridge St. The 85% plans and material specifications have been submitted to the State for approval. We expect to publish the request for construction inspector proposals this month. The project is still on track for construction in 2017. Funds for this project are 80% from the state and 20% from the town.

East Barre Sidewalk Project: This sidewalk is still working through right-of-way. One of the landowners, the Aldrich Public Library, abutting the project has granted their easement required for the project, and furthermore generously waived their right to compensation, in consideration of the benefits they and the village will receive from the sidewalk. Other landowner discussions are still underway. With regards to the grant that the town applied for in October in order to be able to finish the project, announcement letters are being mailed in late January.

There are no updates to the state intersection projects of Rt 14/Sterling Hill/Bridge St., Rt. 110/Mill St./Bianchi St., or Quarry Rd/Rt. 14.

TOWN PLAN AMENDMENTS

Following the Planning Commission's lead, the Selectboard has held two public hearings regarding proposed amendments to the Town Plan that were discussed in detail in the last edition of this newsletter. The public hearings were held on January 3 & January 17, 2017. The Selectboard may act (i.e. approve entirely, make minor revisions, or send it back to the Planning Commission) on the proposed amendments at their February 7, 2017 meeting. If and when the Selectboard approves, the Town will ask the Central Vermont Regional Planning Commission for approval of the plan, in compliance with State law.



The amendments include new language in chapter 3, transportation, regarding the use of fossil fuels; language to protect views in chapter 5; and stronger language in chapter 8, energy, that would possibly give the Town more say over where renewable energy projects go in Town. VOLUNTEER VACANCIES

Many citizens contribute to making Barre Town the wonderful community that we enjoy, including by serving on boards and as part-time officers. Currently, we have need of a few more volunteers! Please consider the following opportunities for rewarding service:

Recreation Board: As you may have noticed from this newsletter, the Rec Board organizes all kinds of fun, and helps our community be healthy and connected throughout the year. It meets the first Monday of the month at 6:00 pm, and members usually spend a few additional hours a month supporting events. The Rec Board needs to fill one vacancy. Deputy Health Officer (DHO): The DHO handles cases involving Vermont's rental housing code, dog bites, and disposal or storage of trash when the Health Officer is not available. The work of these public health officials varies on a call-by-call basis. Typically, there are fewer than 10 calls per year, of which about half require follow-up and written reports. Training is available and the VT Department of Health provides a very useful handbook. The DHO receives a \$400 annual stipend. If you are interested, please submit a letter of interest to the Selectboard, PO Box 116, Websterville, VT 05678. A short resume would be helpful. DOG PARK IN OUR FUTURE?

The town Recreation Board has had at least three discussions about making a dog park. After one of those discussions, dog park users who met with the Recreation Board conducted a survey on Front Porch Forum. The Board hasn't chosen a course of action yet, but there could be a public meeting and another survey to come.

A well-designed dog park would have a small dog area separated from the main section. The enclosures would be double-gated to prevent escapes. The park would offer water (during warmer months) and be easily accessible.

Recreation Board members heard some community members wished to have a well-designed park in the Barre area. The Board invited dog park users to a meeting (December 5). The users noted dogs are better behaved if exercised regularly. Not everyone, however, is able to walk their dogs on the road, a bike path or in the town forest. A dog park provides an option for turning a dog loose to run and to play without fear it will run off or be a nuisance on neighbors' property. Dog parks also are a gathering place where people meet and talk.

The dog park supporters said they'd help with fundraising, construction and maintenance. If and when a decision is made that there should be a dog park and where it will be, site work would include creating a water service and installing fencing with proper gates.

First, however, the Recreation Board has to decide if there should be a dog park, and, if there should be, where it would be sited. The Board has considered several town properties, including an area in the main park and at the East Barre Park. The Board knows it has heard only from supporters and users of dog parks and needs to hear from all town residents. A meeting may be called to collect public input. Another survey, possibly at a town election, may be conducted. Watch the Recreation Board meeting minutes and check the town website announcements for news.

HOMESTEAD DECLARATION FORM

Every Vermont homeowner must file the Homestead Declaration Form (HS-122) every year, regardless of whether a state income tax return is filed. If you don't, you'll pay higher taxes than you need to - \$1,000 more on average in Barre Town! And the lower your income, the more money you can save on your tax bill, by also filing the Property Tax Adjustment Form (HI-144).

The deadline to file the HS-122 with the VT Department of Taxes is April 15, 2017 for the home you occupy as of April 1, 2017. However, you can file the HS-122 as early as January 15, and it is in your interest to file it early – that way, your property tax bills in the coming year are correct from the very first and no adjustments will need to be made afterwards. For the same reason, file the HS-122 early even if you intend to ask for an extension on filing your income tax return.

Often, elderly residents who live in their home and do not need to file a state income tax return are not filing their Homestead Declaration Form, paying way more in property taxes than they should be. Check with your elders – family and friends – to make sure they are submitting their HS-122.

The HS-122 form should be available online in February from tax.vermont.gov. If you have trouble finding it, or don't have a computer, contact the Barre Town Assessor's office; stop by, or call 479-2595 to have one mailed to you. The library, Barre Area Senior Center, and Project Independence can also help you access the form.

If you miss the April 15 deadline, file the HS-122 anyway. If you do not file the form at all, you will be charged the higher, non-residential, tax rate (this year, the rate is .3105 higher per \$100 of assessed value) for the state education tax part of your tax bill throughout the year. (Note that a late filing of the *HI-144* will *not* result in further savings to your *property* tax bill, though your *income* taxes will still be adjusted.)
