#### Firefighters Donate Rescue Tools



The Barre Town Firefighters Club recently ordered two new sets of rescue equipment, commonly referred to as the "Jaws of Life", at a cost of just under \$40,000. The two spreaders and two cutters will be delivered in early February. The purchase of these tools will be *entirely* paid for by proceeds of the last two 52-gun raffles. The East Barre Hose Company (East Barre station club) will make the purchase and donate the tools to the Town Fire Department.

The 52-gun raffle is an annual raffle offered by the fire department. 1,000 \$50 tickets are sold. Each week, using the Vermont Lottery Pick Three evening draw, a winner is determined. The winner picks their gun up directly at R&L Archery after passing a background check just like any gun buyer. To date, the raffles have raised approximately \$140,000 and have purchased a pickup truck with removable wildland skid unit, and an all-terrain vehicle and trailer.

A committee of officers reviewed and demonstrated rescue tools from four different jaws of life manufacturers. In the end the committee elected to purchase equipment from Amkus Rescue Systems distributed by Speedway Safety Service, Inc. of Claremont, NH.

## **Budget Review Underway**

Tuesday, January 30 the Budget Committee kicked-off its review of the proposed 2018-2019 budgets. Every Tuesday night, from 6:30 to 8:00 (and sometimes later) through March 27 the Committee will review proposed budgets. The meetings are held in the Municipal Building and are open to the public. Feel free to pop in any Tuesday night and observe the presentation and discussion. During these weeks the Committee will review the town manager's proposed budgets for the General Fund, Highway Fund, Ambulance Fund, Equipment Fund, Sewer Fund, Water Fund, Cemetery Fund, Building Fund and Sewer Capital Improvement Fund. Meeting agendas are posted on the town website the Friday before the meeting. Minutes are posted within five business days after the meeting.

The General and Highway Fund budgets placed before the voters in May are set by the Budget Committee. The Committee also approves all other budgets and may make a recommendation on water and sewer billing rates. The General Fund budget includes the police department, fire department, recreation division, library contribution and the administration and finance departments. The Highway Fund budget provides money for road paving, streetlights, and winter road maintenance, among other expenses and services.

# **March Town Meeting Day**

The first Tuesday in March voters from around the State gather at their respective polling places to make decisions on local issues. As is customary for Barre Town, this year the March election will be for school issues only.

What's on the School Ballot? Barre

Town has two school districts (Barre Town Middle & Elementary School and Spaulding Union High School. On March 6, 2018 voters will be asked to vote on the standard things such as School Directors (one for Spaulding High School and two for the Elementary School), a School District Treasurer, and to approve a stipend payment for these elected officials. Other equally important questions will be the proposed fiscal year 2018-2019 school operating budgets, whether to allow the School board to borrow operating funds and asking for monies to be put into a capital reserve fund.

Where do we vote? All Barre Town elections are held at the Barre Town Middle & Elementary School gymnasium (70 Websterville Road). Polling hours are 7:00 a.m. – 7:00 p.m. Parking is available in the school lot. Please use the side entrance. If you need assistance getting from the parking lot to the gymnasium, please contact the Town Clerk's office at 479-9391 prior to election day.

<u>Can't make it to the polls – request an early ballot.</u> To request an early ballot for any election contact the Town Clerk's Office (479-9391) or by email (<u>dkelty@barretown.org</u>).

Don't have time to register to vote? No problem... just contact the Town Clerk for an application or go online to the "My Voter Page" (hosted by the Vermont Secretary of State). This online site provides an individual many options for managing your voter rights. You can register to vote, change your voter registration from one Town to another, obtain information on state and federal elections, request and find the status of your early ballot request. What is a Non-Partisan Town Caucus? A Town Caucus is a meeting of the members of a political party who gather to select/nominate a candidate for an elected office (Selectboard, Moderator, Town Clerk, etc.). Non-Partisan means that the political parties hold their meetings together, not separately.

Why does Barre Town hold a Caucus? Many years ago, there were issues in recruiting individuals to run for an elected office. To ensure there is at least one candidate for each municipal office the decision was made to hold a Non-Partisan Town Caucus. While the meeting holds no "official standing" and is not required by law, we continue the tradition today for the same reason.

Barre Town's Open Meeting, (first Wednesday in May) is a from the floor vote. It will be held on May 2, 2018, in the Municipal Building, Selectboard meeting room, and begins at 7:30 p.m.

The second vote is the Election of Officers and Voting by Australian ballot which will be held on Tuesday, May 8, 2017 at the Barre Town Middle & Elementary School Gymnasium. Polling hours are 7:00 a.m. – 7:00 p.m.

Dog Park: The Dog Park has made considerable progress since the last newsletter though fundraising need remains. Thanks to volunteers and Lafayette Highway Specialties, the fence posts and fencing are up. Gate installation remains to be



done. Once the park is open users may park in the school parking lot. Remember to keep your dog leashed until you are in the Dog Park with the gate securely closed behind you. Waste receptacles are available, but owners must pick up after their dog (s). No puppies under 4 months, or food, please. Other (common sense) rules will be posted at the Dog Park.

As of this writing, the Dog Park has raised \$5,386.79 after fence post expenses. Another \$2,838.46 needs to be raised to pay for the fencing in full. Based on survey results, the Committee would like to raise enough additional funds for benches, dog waste composter, shelter for humans, and more. Groomed Snow Trails: As in previous winters, Millstone Trails Association (MTA) is grooming loops in the Town Forest for XC skiing, snowshoeing, and fat biking this winter. The trails go over varied terrain and three

different loops are possible when conditions are favorable. To access the groomed trails in the Town Forest, park at either Town Forest parking lot, at 44 Brook St., or the end of Barclay Quarry Rd. Easier options for low-key XC skiers are once again being groomed on the Millstone Hill West bike path (by the Barre Town School), and two short loops in the Barre Town Rec Area. # **Charity Winter Softball Co-Ed Tournament**

Since 1999 a small number, at first, and recently a very, very large number of co-ed softball teams have met in the

winter at the Barre Town Recreation Area to play a double elimination tournament. At first the tournament benefitted the Central Vermont Co-Ed Softball League. After a short time the tournament proceeds were used to help a family with a child battling a serious



illness. In the years after the inaugural tournament the event organizers have: raised over \$375,000 for charitable giving; given 26 Vermont families financial support; furnished a comfort room at Central Vermont Medical Center's cancer treatment center; developed the 501 (c) (3) Freezing Fun for Families organization; and set a Guinness World Record for World's Largest Snow Softball Tournament.

The tournament will be held in 2018 over the weekend of March 2 - 4 at the Recreation Area. The tournament is capped at 68 teams. The registration fee per team is \$300. Play begins at night on Friday, March 2. Play reaches its highest point on Saturday when up to seven softball fields are laid out and used in the recreation area. The Town assists with the tournament by donating use of the recreation area and field lights. # **Dog Licensing Time!**

Do you own a dog? Does the dog live in Barre Town? If you answered yes to both questions then by Vermont law (20 VSA Sections 3541-3591, 3801-3813) your pet is

required to be licensed annually in the town where it is kept.

What do I need to get a dog license?

- 1. A copy of a current rabies certificate.
- 2. Payment for the license (\$10.00 for a spayed or neutered animal and \$14.00 for an animal that is not fixed).
- 3. Obtain the license by <u>April 1, 2018</u>. If your pet is found to be unlicensed after April 1, 2018 you will be charged a late fee to obtain a license plus you could receive a fine of \$35.00 from Barre Town.

#### Where do I go to get a license?

The Town Clerk's Office. In Barre Town, if the office has a current rabies certificate on file then a license renewal form was mailed to you in January. Once you receive the form be sure to check the information carefully (make corrections if necessary), sign, enclose your payment, and return to the Town Clerk's Office in the detachable self-addressed envelope.

Should the Town Clerk's Office have a rabies certificate on file, but it will expire before April 1, 2018, then you will be mailed a postcard reminder.

Be a responsible pet owner! Make sure your pet is licensed, has a current rabies vaccination, and the current year license tag is affixed to your pet's collar.

#### **Update to Town Charter Amendments**

On January 1, 2017 state law changes went into effect regarding elections and the duties of the Board of Civil Authority (BCA). This prompted a review of our Town Charter which resulted in a few amendments which were approved by the voters at the May 9, 2017 Annual Town Meeting.

Those amendments included:

- Section 6(b) eliminating the need for the BCA to update the checklist on the Wednesday before an election (now there is same day voter registration).
- Section 6(b) changing the responsibility of posting the checklist (still law) from the BCA to the Town Clerk and to post said checklist 30 days (not 4 days) before an election.
- Section 6 (e) adds a sentence pertaining to the BCA meeting quorum which will remain a majority of members for all meetings except those pertaining to checklist changes (only 3 are required).

The voter approved charter amendments were forwarded to the Legislature in House Bill 568. Testimony was taken in the House Government Operations Committee resulting in the bill passing out of the Committee on January 19, 2018. A floor vote is expected in the very near future. Once approved by the full Legislature the charter amendments must be signed by the Governor.

# **Brookfield Ambulance Service**

On January 1, 2018 Barre Town EMS took over EMS cov-

erage for the northern portion of the Town of Brookfield. Consideration of this change has been talked about for many years. Now after six months of negotiation and state regulations the change was finalized. The Brookfield select board has consid-



ered this matter for years based on board discussions and a town vote. Brookfield's geography and limited access to Interstate 89 has always been the driving factor for this change. While White River Valley Ambulance will keep servicing the southern portion of the town the changes will reduce the response time to the northern sections. However, it was made very clear to the Town of Brookfield that while Barre Town EMS will have shorter response times than they have seen in the past the times will still be more than 20 minutes in most areas.

## **Homestead Declaration Form**

Attention Vermont homeowners! You must file the

Homestead Declaration Form (HS-122) every
year, even if you don't have to file a state income tax return. If you don't file an HS-122,
you'll be paying higher taxes than you need to

\$1000 more, on average, among Barre Town property owners! And the lower your income, the more money you can save on your tax bill.

The deadline to file HS-122 with the Vermont Department of Taxes to avoid the \$15 penalty is April 17, 2018 for the home you occupy as of April 1, 2018. However, you can file the HS-122 as soon as the form is available, and it is in your interest to file it early – that way, your property tax bills in the coming year are correct from the very first. For the same reason, file the HS-122 early even if you intend to ask for an extension on filing your income tax return.

Often, elderly residents who live in their home and do not need to file a state income tax return are not filing their Homestead Declaration Form, paying up to thousands of dollars more in property taxes than they need to. Check with your older family members and friends to make sure they are submitting their HS-122 forms.

The form will be available online. Visit tax.vermont.gov, and type "2018 HS-122" into the search box at the upper right of the page. If you don't have a computer, you can get a form from the Barre Town Assessor's office. Stop by or call 479-2595 to have one mailed to you. The library, senior center, and Project Independence can also help you access the form.

If you miss the April deadline, file the Homestead Declaration Form anyway, no later than October 15, 2018. If you do not file the form at all, you will be charged the higher, non-residential, tax rate for the state education tax part of the tax bill throughout the year, and pay anywhere from \$50-\$6000 more than you needed to.


Further, if you have income but not from any current job, you should file a Household Income Form (HI-144) with your HS-122. For example, if you only have income from social security, disability and/or retirement, you can file your HI-144 at the same time as your HS-122 and potentially reduce your tax burden even more.

# **School Property Transfer**

The Barre Town Middle and Elementary School board and Town are working together to have the School transfer ownership of about 68 acres of land to the Town. The land would include the entire Recreation Area and most of the school's wooded acres. The School would retain 20 acres, including the large parking lot, the building and playgrounds and some wooded land behind the building. The 20 acres would allow the School to add-on in the future and not exceed the zoning by-law for lot coverage.

Last summer, after the Town subdivision process was completed and during the state water and wastewater permit phase, it was learned the school was subject to an Act 250 land use permit. Because of the old land use permit an amendment was needed. Also the subdivision needed to show easements the School would have to deed to the Town. The easements are for water, sewer and electric lines across land the School would retain. No present day staff worked for the Town when those lines were laid in the ground; various forms of field verification were needed to place the easements on the plat.

That plat change was made. The Act 250 permit amendment application was completed, signed and submitted in January.

When the permits are in hand the School Board will publish and post a Notice of Proposed Conveyance.

Amkus is a proven leader in the rescue tool industry having



been around for decades. Amkus is the supplier of rescue equipment for both NASCAR and NHRA.

Due to the advancement of battery technology, a substantial change with the new jaws of life equipment is being made. The new jaws will be battery operated as compared to using hydraulics like

the current version. The battery operated equipment is much more versatile, easier to setup and start cutting, less cumbersome, quieter, and there are no hydraulic fluid leak worries. While the committee went into the demonstrations with some doubt about switching to battery operated equipment, those concerns were quickly quelled during the demonstration. The battery performance was extremely good; however adaptors allow the units to run off a generator if necessary. Each station will get a set of tools which consist of a spreader and cutter. While the purchase comes with training, the new tools should go into service almost immediately.

The Budget Committee has ten members - the five selectboard members and five citizens. As stated in the Town Charter the Town Clerk-Treasurer appoints one member and the Selectboard two memebers. Those three people pick two more registered town voters to complete the Committee. This year the Clerk-Treasurer appointed Rob LaClair. The Selectboard appointed Norma Malone and Cedric Sanborn. The last two seats were filled by Justin Bolduc and Kevin Delude.

#### **Project Updates**

East Barre Sidewalk: The Town is close to finalizing rightsof-way on this sidewalk project along the south side of Mill Street and a bit on Websterville Road to the East Barre post office. The project is being paid for via federal grants administered by VTrans, requiring 20%, or \$50,080, cost share from the Town. Construction is still planned for 2018.



Forest Logging: There will be no logging in the town forest this winter. The logger decided not to finish the contracted logging. (There was one more large section to log.) He forfeited a \$500 performance bond. When that decision was learned there was not enough time to seek bids, award a contract and finish the

logging this winter. This coming summer town staff and the consulting forester will consider the unfinished logging and the forest management plan to decide the next course of action.

Rt. 14/Sterling Hill Rd./Bridge St.: Construction now is expected during the 2020 and 2021 construction seasons. Relocating a water line in Rt. 14 is being planned for 2020. The intersection improvements would be made in 2021. AOT still has stormwater permit details to work out. The right of way acquisition has to be completed, but final plans are needed first.

On January 23 the selectboard was slated to approve a Finance and Maintenance Agreement. The town attorney suggested some revisions so no action was taken. The town attorney and AOT staff are working on the F&M Agreement.

The project will broaden the turning radius out of Bridge Street onto Rt. 14, add traffic signals, add left turn lanes on Rt. 14, add pedestrian crosswalks, and improve the sidewalks.

Websterville Fire District #3: Restoration of road and property disturbed for installing the new water pipe and service pipes to homes was completed last November. The emergency power generator and automatic transfer switch at the pump station/office were installed and completed. The electric panel upgrade at the treatment plant was finished. The WFD is working, as an additional improvement, to purchase and install an emergency power generator at the treatment plant.

As of this writing a VT legislative bill to merge the WFD and town water system has not been introduced..

# **Central Vermont Internet Vote**

On January 16 the Selectboard voted to place the Central



Vermont Internet (CVI) article on the May Town Meeting ballot. Voters will decide if Barre Town will join the proposed communications union district. Actually, by May it shouldn't be a proposed district. Nine other central Vermont municipalities will vote on the ques-

tion at their March Town Meeting; on May Town Meeting it would be a pending district. Those towns voting are: Berlin, Calais, East Montpelier, Marshfield, Middlesex, Northfield, Plainfield, Williamstown, and Worcester. As of this writing Montpelier and Barre City had not decided if the question would be on the ballot but were planning to decide late in January.

The ballot question presented by chief organizer Jeremy Hansen of Berlin is: Shall the Town of Barre enter into a communications union district to be known as Central Vermont Internet, under provisions of 30 V.S.A., Chapter 82? Town residents wanting to research the proposal could read Chapter 82 of Title 30 of the Vermont Statutes. The CVI would be very similar to the East Central Vermont Telecommunications District d/b/a EC Fiber, a district of 24 towns. A few of the larger and closer member towns include: Chelsea, Brookfield, Bethel, Hartford, Montpelier and Randolph. Central Vermont residents' opinions about the question might be shared in the weeks leading up to the March Town Meeting. Barre Town will post information on its website before this May election.

If voters decide to enter CVI the Selectboard will appoint a representative to the CVI board of directors.

For the last year or so, the Barre Town Planning Commission has been working in conjunction with the Central Vermont Regional Planning Commission to create a comprehensive energy plan. The plan will address many issues and will hopefully provide the Town with substantial deference (to give substantial and meaningful weight) during Public Utility Commission proceedings when reviewing renewable energy projects in Barre Town. Part of the plan will include a target for Barre Town to supply renewable energy aimed at helping the State meet its goal of being

90% renewable by 2050. A big part of the plan will also include energy conservation and how important it is for Barre Town to do what we can to conserve energy.


Residents and businesses have an important role to play in meeting the state's, and eventually the town's, energy goals. Types of actions include not using more energy than needed (conservation), upgrading to more efficient appliances or vehicles when appropriate (efficiency), and installing renewable energy. These actions can save you money, provide better control over energy bills over time, and make us better stewards of shared resources. It can even be fun - many Vermonters enjoy the challenge of putting together just the right combination of actions to make their homes net zero energy users. The goal may sound far-fetched, but, thanks to current technology and access to plenty of good technical support, getting to net zero may be more doable than you think. Efficiency Vermont, the state-funded, state-wide resource for energy efficiency for residential and commercial buildings, is a great first -stop resource. Here in Barre Town municipal operations, we are striving to do our part. The biggest energy users among the town buildings underwent energy efficiency audits several years ago. We have been working our way through the list of recommendations each budget year since. These include lighting retrofits, motion sensors for lighting, and weatherization. In 2017, our freshly assigned "account manager" at Efficiency Vermont identified more opportunities, thanks to newer efficiency technology like variable speed pumps for heating distribution systems. Some of these have been added to the Town's 5-Year Building Plan. On the renewable energy front, Barre Town developed its own 500 kW solar farm on old industrial land, offsetting much of our annual electricity bill and some of Barre Town School's as well. Stay tuned to the newsletter for updates on the Town's energy plan and related activities.
