Christmas Tree Collection

If you are a new Barre Town resident or aren't aware,



the Department of Public Works (DPW) will pickup and recycle your discarded Christmas tree. The service is provided the first two weeks of January. (See schedule below). Service is suspended temporarily if DPW has to plow, salt and sand roads.

To use the service, completely remove

all lights, decorations and any string or garland. Place the tree by the street or road before the end of the collection week for your area. If the tree is still there after your collection period call the DPW (476-3522) or Town Manager's Office (479-9331).

The Town provides this service to help residents dispose of a large and eventually unsightly item. Furthermore, the Town is interested in not having trees tossed into waterways or drainageways where the trees might cause minor isolated flooding. The Town also is interested in reducing outdoor fires. Landfilling organics such as a Christmas tree no longer is a legal alternative.

Trees collected by DPW are added to the brush pile at the lawn waste site and chipped for wood mulch. You can re-use your tree next spring or summer.

January 13-17: South of 302, including East Barre, Websterville, Graniteville, Quarry Hill, Sterling Hill, South Barre, West Hill.

2020 Presidential Primary Election Must Know Information

State law allows a voter to make an annual request to re-

ceive early ballots for all elections. However, the request will be valid for only the calendar year in which it was made. For those of you that have made such requests in the past, remember after January 1, 2020 you will need to make a



<u>new request for calendar year 2020</u>. To renew or make a request, visit or contact the Town Clerk's office (802-479-9391) or go online to the Secretary of States "My Voter Page" and use their portal (<u>https://mvp.sec.state.vt.us</u>). Hint – you will need to know your Vermont driver license number or the last 4 digits of your social security number.

Speaking of 2020, the <u>Presidential Primary Elections</u> will be held on March 3, 2020. The Presidential Primary is different than most elections in Vermont. V.S.A. Title 17, Chapter 57, Section 2704 states that in a Presidential Primary Election you must declare a party and the party choice will be noted on the entrance checklist (which is a public record).

- The Housing Advisory Committee advises the Selectboard on housing-related matters. The HAC meets as needed. There is one vacancy at present.

•CV Regional Planning Commission provides a number of services to member municipalities, including but not only emergency management, traffic counts and road culvert inventory. CVRPC meets monthly. At present there is a vacan-

cy in the alternate position.

- Central Vermont Internet Board (CV Fiber) is working to bring community-owned internet to the region. CV Fiber meets monthly. There is one alternate vacancy available.
- The Phoenix House Working Group is a public relations committee for the Phoenix House in South Barre. The House provides structured transitional housing for people convicted of a drug or alcohol use related crime. The seat for a South Barre resident is vacant.

miles) run/walk on Thanksgiving morning. Depending on the weather, 175-200 people (and some dogs) will participate. There are two possibilities for the race course: a good weather course and a bad weather course. The good weather course starts on Bolster Road near the Municipal Building parking lot. The bad weather course begins in the bus loop in front of the town school. Both courses head down

Websterville Road between the cemeteries to the 4-way intersection and then turn out Graniteville Road. Drivers on Websterville Road and Graniteville Road are urged to be patient and drive cautiously near participants.

Reappraisal Update

In September the Selectboard approved an addendum to interim town assessor Russ Beaudoin's assessing services contract. The addendum addresses performance of the town-wide complete property re-valuation. Beaudoin will manage the reappraisal in his role as interim town assessor. Experienced data collectors have been hired to inspect residential properties. Beaudoin will inspect all commercial and industrial properties.

The reappraisal is underway. Beaudoin decided the northwest corner: Averill Rd., LePage Rd., School Rd. area would be the first area of town to be inspected. From that area inspections will move clockwise around the Town. Post cards are mailed to property owners in an inspection area two weeks before the inspections begin.

To date, 167 exterior property inspections and a few interior inspections have been completed by data collectors. (They have a Town issued photo ID. If someone claims to be a property reappraisal inspector and doesn't have the Town photo ID do not let them into or onto your property.) The completed inspections are all in the first area. Post cards have been mailed to owners in the second area - near Farwell Street. Deep snow, icy conditions and frigid cold temperatures will suspend outdoor inspection work.

The Selectboard decided to begin the reappraisal because the last reappraisal was completed in 2004 and because the Town's common level of appraisal (CLA), a comparison of the last assessed value of a property to its recent sale price, stands at 85.32%. A new state law requires a reappraisal when the CLA is at or below 85%. Money (from a state grant) in the Town's Reappraisal Fund will pay for the reappraisal. The addendum calls for the reappraisal to be complete for the 2021 Grand List and tax bills.

No Snow in Roadway

Winter time is upon us - which brings the yearly ritual of cleaning the snow out of our sidewalks and driveways. This event has been made easier by the use of snowblowers, snowplows, snow scoops and even better designed shovels. When we clear the snow, we then become somewhat challenged as to where to put the snow. So, we push, shovel, plow or blow it either into or across the road or sidewalk thinking it will just melt or be plowed away.

It is a violation of the Barre Town Code of Ordinances, Sec. 6-2, which states: any snow cleared from driveways, parking lots, roadside parking spaces, lawns or other residential, commercial, agricultural or industrial properties shall not be deposited within the right-of-way of any town road or highway. If this happens, in the judgement of a Town police officer, the property owner shall be cited for a violation.

When you plow across the road, it leaves some snow which will freeze, causing a dangerous situation. Drivers can hit ice spots or lumps left by the snow causing them to lose control of their vehicle and leave the roadway. Also damage can occur to the Town snowplows which can be costly. Try to put snow on the low side of your driveway. That way when the plow goes by it does not get put back in your driveway or walkway. You can see up the road better also.

Please remember that if you violate this ordinance you



could receive a civil ticket along with a fine of \$60. By Harry Hinrichsen, Town Engineer

Mailboxes and Snow

Snowplow season is coming. To help keep your mailbox safe, place a reflector high enough so a plow driver will see it above the snowbank, and

keep the ground or road under your mailbox clear of snow. In the later winter months, snow can build up high enough that the town's plow can no longer clear the box if they happen to edge underneath them. If you do suspect that a town plow damaged your mailbox or post, call the DPW Office at 476-3522 with your address. If the town can determine that plowing did the deed, town workers will replace with basic materials.

Winter Parking Ban

Each year, from November 1st through April 1st the parking

of vehicles within the right-of-way of public roads between the hours of 11:00 p.m. and 7:00 a.m. is prohibited. The town notifies the public of this section each year by news releases issued to the local news media by the town manager's office in October. In addition, the town manager may, by executive order, prohibit



parking at any other times of the year if emergency road conditions exist. Vehicles found in violation will be issued a municipal ticket and fined \$10.00. Repeated violations, vehicles found to cause a safety hazard, or vehicles hindering the plowing of town roads will be towed at the owners expense, which may be between \$100.00 and \$200.00. Please help keep our roads safe, and help our highway department do their job by making sure your vehicle is not within the town right of way.

National Teen Driver Safety Week

National Teen Driver safety week took place October 20th



through October 26th, 2019. This week was dedicated to raising public awareness, and finding ways to reduce teen injuries and deaths as a result of motor vehicle

crashes. Important subjects to discuss with teen drivers are speeding, seat belt use, cell phone use, and impaired driving (both alcohol and drugs).

In 2017, on average, a pedestrian was killed every 88 minutes in traffic crashes. 1,830 young drivers ages 15 to 20 years old died in motor vehicle crashes. In crashes where use (or non-use) of seat belts was determined, 47% of youths who died were unrestrained.

Talking with the young drivers in your household and making them aware of how their actions could affect not only them, but other drivers on the roadway will make our town safer for everyone.

Sand Available For Safety

Residents may have a steep driveway. Everyone has some walkway that could get icy. The Town Depart-

ment of Public Works offers free sand to help residents be more safe.

The sand for slip protection and traction is placed outside the DPW Yard gate at 129 Websterville Road. The sand is for Barre Town residents to use at their home. The sand is



available now. It is advisable to collect some sand before a storm. Sometimes during or right after a storm many people try to get sand creating a waiting line. Also the pile could be depleted and during a storm the DPW crew is busy maintaining the roads and can't promptly replenish the pile.

Visit the sand pile early: Respect the rules posted on the fence; take a reasonable amount. It is not intended for loading a dump truck.

Winter offers a whole host of fun activities in Vermont, but did you know that nationwide 1 in every 7 reported home fires is related to heating a home? In addition, 1 in every 5 deaths Page 5

resulting from a home fire is due to heating. If these statistics don't get your attention, remember that a large percentage of the nation's population doesn't have to heat their homes regularly.

Winter always brings a spike in fire calls for the Barre Town Fire Department. It is imperative to be mindful and careful when using heating appliances and putting combustibles too close to them. *All heating appliances should be checked and cleaned annually by a professional installer* to ensure proper function. *Make sure that nothing that can burn is within 3' of any heat source like a fireplace, wood stove, radiator, or space heaters.* If you burn wood, *have your chimney cleaned by a professional chimney sweep before the heating season starts.* Use well-seasoned wood, try not to let your fire smolder (brisk fire is best), wet wood or slow-moving fires can cause creosote buildup. Many times we go to a chimney fire even after the chimney was cleaned at the beginning of the year.

Christmas is another period of increased danger for fire. More than half of all home decoration fires in December are caused by candles. The top three days for home fire caused by candles are Christmas Day, New Years Eve, and New Years Day. *Keep candles at least 12" away from anything that will burn and don't leave them burning unattended.*

Other important tips: Be careful not to overload power outlets or extension cords. Keep cord lengths as short as possible and make sure they aren't damaged or could become damaged. Seems like common sense but people die every year from poorly vented or none vented generators. *Never use a generator in or near the home*. Finally, as always, make sure you have working photoelectric smoke detectors as well as carbon monoxide detectors. You can't have too many of either.

Project Updates

Lower Graniteville Playground: Thanks to enthusiastic hard work by Spaulding High School football players, coaches, and parents, several members of the Rec Board and the neighborhood, and supervision provided by MRC Recreation, the Lower Graniteville Playground Community Build was a success! The group installed a rocket ship climber for 5-12 year olds and a structure for 2-12 year olds all in one Saturday. The hill slide was installed by contractor Pettinelli & Associates. The length and height of the slide required reshaping the hill. The area will be fenced off until the new grass on the reshaped hill is strong enough. The rest of the playground is open for play.

Rt. 110—Mill St. Intersection: The state's contractor, J.P. Sicard, started work in September. Two unforeseen conditions required work pulling the crew away from the contracted assignment.

As of November 12 all curbing is done, including granite curbing on both sides of Mill Street. About 180' of concrete

sidewalk has been poured. All drainage is complete, and the pavement has been milled in preparation for paving. As of November 12 Sicard has to finish the concrete sidewalk, the paving on Mill Street and Rt. 110, painting road lines and the restoration work.

During the project Sicard encountered a buried sewer manhole at the bottom of Mill Street. Because of the depth of the sewer line in relation to the regraded street, the contractor had to relocate 225' of 10" PVC sewer pipe and install a new sewer manhole. While sloping the bank along Rt. 110 the contractor struck a concrete foundation wall. An 8' x 8' section of that wall had to be removed.

This 100% federally funded state project has shifted Mill Street to create a truer T intersection with Rt. 110 improving sight lines. The end of Old Route 302 was narrowed to better direct traffic reducing uncertainty of what a driver on Old 302 will do (where the driver will turn). Sidewalk will be extended from Summer Street to Old 302, and a curbed island at the corner of Bianchi and Rt. 110 will give that intersection definition and allow a stop sign to be installed.

After laying its water pipe from Old 302 to Bianchi the Town has not been involved in this project.

I-89, Exit 6 Work: Both northbound lanes of I-89 near Exit 6 were re-opened to traffic Saturday, November 9. The project is essentially wrapped up.

Seeking Citizen Members for Budget Committee

The Town Charter states the Budget Committee will have ten members: the five members of the Selectboard and five registered Town voters. Per the Charter, the Budget Committee's duty is approving seven of the nine Town fund budgets and approving the other two (General Fund and Highway Fund) presented to voters for approval at May Town Meeting.

The Selectboard is seeking letters (letters or email) of interest from registered Town voters. The Selectboard will appoint two of the five citizen members. The Town Clerk-Treasurer appoints one member. Those three appointees get together and select two registered voters to fill out the Committee.

The Committee meets on Tuesday nights starting at 6:00 p.m. The Committee begins meeting the last Tuesday in January and meets weekly until the end of March. A special meeting or two may be needed. The Committee reviews the Town Manager's budget for nine funds. It approves (sets) the final budget for the Ambulance, Equipment, Sewer, Water, Cemetery, Building and Sewer Capital Improvement Funds. The Committee also studies the two largest budgets, General and Highway, and finalizes these budgets for voter approval.

Committee members have an important role in the Town finances and operations. During the review process the Committee receives much operational information and hears from department heads. While doing their part for the Town, Committee members gain a broader understanding of Town operations.

If you are not a snowbird and remain in Town during February and March, consider submitting your name for the Committee.

Would You Need Help in a Disaster?

Emergencies can take many forms. Ice storms, floods, fires, major traffic accidents, and similar events can cause power outages, isolate individuals, or prompt the need for evacuation. For elders, or for people with certain disabilities, such events, if prolonged, can become life-threatening if no one is available to help.

CARE (Citizens Assistance Registry for Emergencies) was created by state agencies and United Ways of Vermont to help. CARE is the means for emergency responders to identify and aid those who would need them if there were a widescale emergency. Examples include, but are not limited to, those who would need transportation, a wheelchair van, or have electricity-powered medical equipment.

If you or someone you know might need special help in such an emergency, please register with CARE. The registration form asks for phone numbers, email, needs, and reasons. You may be contacted annually to update your registration. However, please be proactive and update your registration as soon as there is a change to your contact information, especially your home address.

CARE registration does not guarantee your safety, and you will still be responsible for contacting emergency personnel should you feel you are in danger. But, registering with CARE will help first responders help you. Emergency Shelter in Barre Town



Barre Town does not have a long-term emergency shelter, the BOR in Barre would be used if long term sheltering was necessary. However, Town residents should be aware that we do have short term shelters in the event of an emergency. The Town would open Town own build-

ings for a place to go until either the emergency is over, or a long-term facility has been opened.

If your power is out at your home or it is in danger, and you and your family may need to stay warm, or you may have medical devices that depend on power, the first and primary place to turn would be the East Barre Fire Station located at 119 Mill Street in East Barre. Both of our fire stations are fully functional with emergency backup power in the event of a power outage. The East Barre station is better suited to host residents and can provide warmth and power. A limited number of cots are also available along with a small kitchen and restroom facilities. If you have pets, we'd have to work together on that and handle them on a case by case basis.

If you are in a situation where you can't stay in your home during an emergency, chances are the fire station is already open. However, if you want to check or call ahead, you can use the following numbers: Fires stations, 479-9878, EMS station, 476-3147, or the police at 479-0509.

Ice Preparations and Precautions

It is almost a sure bet a freezing rain event causing ice build up on ground surfaces, tree branches and overhead

utility wires will occur during the winter. Not if it will happen, but when. Icy conditions on roads, walkways, driveways, or paths, and on trees and wires pose unique threats.



During the winter be aware of the weather forecast for the Barre area; check forecasts regularly.

If you must travel by car and know roads will be icy, allow more travel time so you can drive slower. Driving slower is the only viable option on ice. Snow tires and four wheel drive are not cures.

Obviously, use extreme caution if you must walk on icy paths, walkways, decks or patios, sidewalks or driveways. Prepare for icy conditions as needed for your situation. Don't walk on the ice, if not necessary. If it is necessary, have deicer and/or sand on-hand. *(See sand pile article on page 4.)* A walking stick or ice cleats might be helpful.

Ice build up can break off tree limbs or fell a tree in a road or on your property. Check the area around the branch or tree carefully before attempting to move it. Be certain the fallen branch or tree didn't pull down a utility wire. Assume any downed wire is an electrical wire and is live (charged). Stay clear and keep children and pets clear of any downed wire. Call 911 to report the wire (and tree if in the road). If the conditions that caused the tree or branch to come down haven't changed be aware more limbs or trees could fall.

Housing Rehab and Weatherization Loan Money

Do you own and live in a Washington County home that is

No, No, Don't Flush It

The Green Mountain Water Environment Association



(GMWEA) has released its second brochure about wastewater and water quality. The new brochure is titled "Don't Flush It." The brochure is for everyone. The information and advice applies to residents with an on-lot septic system and to residents using the

Town's sewage collection system.

Chemicals in drugs (medicines) and personal care products (PCPs) disrupt an on-lot septic system and can seep into ground water. "Also, some antibiotics and antibacterials can impair performance of septic systems and wastewater facilities." Wastewater treatment doesn't treat all chemicals found in medicines and PCPs. These chemicals end up in the receiving river and lakes damaging the ecosystem.

"Never dispose of any medication - whether prescription or over the counter - in your sink drain or toilet." The Barre Town Police Department has a free drug drop-off box. It is for any over the counter or prescription drug. There is no requirement to register or show what you are dropping into the box. The box is in the lobby of the police station in the Municipal Building. Call 479-0509 for more information.

"Many PCPs for body care and comfort also put unnatural chemicals into septic systems and wastewater facilities. PCPs contain thousands of chemicals; some aren't so bad, but others show up frequently in health and environmental warnings. Always among the top ten worst PCP chemicals are: Phthalates, parabens, formaldehyde, siloxane (drug name often ends in - methicone), and diethanolamine." Try to purchase PCPs that don't contain these chemicals.
