# New Assistant Town Manager Hired

Elaine Wang has been hired to fill the vacant Assistant Town Manager position. She and her husband have been residents of Barre Town since 2009.

Since graduating from the University of California at Berkeley and the University of Vermont, she has worked at an environmental outreach nonprofit based in Burlington, VT, Chittenden Solid Waste District, Transportation Research Center at UVM, and most recently at the Institute for Sustainable Communities (ISC), an international development nonprofit headquartered in Montpelier. During her seven and a half years at ISC she supported the management of ISC's projects in the U.S. and Asia benefitting the human and natural environment, health and safety of factory workers, and project management skills of nonprofits. She also researched and wrote about U.S. municipal best practice and traveled frequently for ISC around the U.S. and Asia, most often China.

After working for years to support wonderful but distant communities, Elaine became interested in a career change to local government management and the opportunity to improve the community where she lives and can interact daily with those whom she serves. She has been working part-time for the Town as Special Projects Assistant to the Town Manager since August 2015, managing the Revitalize Trow Hill Playground project and the Bridge Street Sidewalk Transportation Enhancement Project, among other tasks. Her first day as the Assistant Town Manager was April 4, 2016.

Elaine has been an Alternate Commissioner on the District 5 Environmental Commission since 2012 and a member of the Barre City Energy Committee since 2012 and will continue in these capacities.

# **Budgets & Voting**

Come May 10, or sooner if the early voting option is exercised, town residents will elect town officials, decide if proposed General Fund (GF) and Highway Fund (HF) budgets are approved and decide if sixteen not-for-profit agencies will receive a donation.



The article on page 3 provides details of voting options and about voting on May 10. It is not necessary to go to the polls on May 10 or even go to the Town Clerk's Office to vote. Voting at home is possible; call the TCO and ask about an early voting ballot.

The ballot lists articles about approving the GF and HF budgets, the two budgets supported by property tax revenue. For the proposed fiscal year (FY) 2016-2017 GF budget property taxes account for 84.7% of all revenues. In the HF property taxes supply more of the revenue - 92.5%.

Per the Town Charter, the Budget Committee determined the amounts of the GF and HF budgets placed on the ballot. The Committee also determined the amount of the other seven budgets supported by other revenue sources. Those budgets (in order from largest to smallest) are: Ambulance, Equipment, Sewer, Water, Cemetery, Building, Sewer Capital Improvement Fund.

Citizen's serving on the Budget Committee with the selectmen were: Joanne Cyr, Bob Nelson, Val Vallerand, Paul White and Bill Wolfe. Their service is deeply appreciated.

# **Police News**



The new Barre Town website is up and running. We encourage everyone to check it out as soon as you get a moment. One new feature is the Crime Tip Form. This form is a great place to report activity that you feel may be criminal but not in need of immediate police response. This information will be sent securely and directly to

the Chief of Police, however, you will not receive a response immediately. If you have a crime that needs to be reported immediately please call dispatch at (802) 479-0508.

Warmer weather is here and more people will be out and about. Children will be out playing or headed to local playgrounds. There is also an upswing in the amount of walkers on the roads. Please slow down when you see people, especially children, near the roadway. Children may dart out into traffic suddenly without looking.

The Barre Town Police radar trailer is already being put out in different parts of the community. If you would like to put the radar trailer to use in your neighborhood please contact the Barre Town Police Department at (802) 479-0509.

This year the Barre Town Police Department was awarded a Governor's Highway Safety Occupant Protection Grant. This grant helps pay for more police patrols to combat aggressive and distracted driving including speeding, cell phone use, texting, and educating people on use of seat belts and current Vermont Statutes.

The Rock of Ages Company has brought to our attention that there has been an increase of vandalism and trespassing on their property. The police and Rock of Ages are working together to deal with these issues. We would like to remind you that Rock of Ages does not want people on their property. Also, please remember that swimming in abandoned quarry holes is prohibited. It is incredibly dangerous as many times there is no means of egress and objects can be hidden just underneath the surface of the water.

National Police Week is May 15 – May 21, 2016. Barre Town Police along with police departments throughout the nation observe this through many different events. The Barre Town Police Department participates in local events.

# What Do I Need A Permit For?

**Driveway**: Driveway Permits are issued by the Town Engineer's Office for both new and existing driveway work. The permit protects the Town's interest in the road relative to drainage along the road, drainage in the driveway and grading a the driveway apron. Permits are required for almost any work done on an existing driveway in the vicinity of the Town road end of the property. If you are planning to do driveway improvements such as re-graveling, regrading, culvert work, repaving or resurfacing, please contact the Town Offices at 479-2595 for a Driveway Permit. You do not need a permit if you are applying sealcoating. The cost of this permit varies.

<u>Fireworks</u>: Application required at least 15 days prior to event. The cost of this permit is \$15. Contact the town clerk's office.

<u>Outdoor Burning:</u> A permit is required from the Fire Warden (802-498-8694, leave message) for legal burns of clean, natural wood and vegetation only. There is no cost for this permit.

Home Improvement(s) or New Construction: Exterior renovations or construction more than 64 square feet will need a permit. Contact the Zoning Office (802-479-2595) for more information. The cost of this permit varies.

# **Declaring Your Homestead**



Each person who owns property and lives on that property MUST declare homestead each year by April 15. If they do not, they will receive a penalty. Even if you do not believe you owe property taxes, you must declare homestead in or-

der to qualify for Property Tax Adjustment. Filing a Homestead Declaration is easy and can be filed online. To insure you are taxed at a residential rate please file as soon as possible. If you wish to file for a property tax adjustment claim (tax credit) and are not prepared to do so when filing your homestead you can do so at a later date.

The State of Vermont opens their website in mid January. You may file online at www.tax.vermont.gov.

If you are not able to file online please feel free to call 479-2595 and we will provide you with a form to file.

# Continued - Budgets & Voting



The GF and HF total \$6,250,156, which is \$187,975 more than the current budgets. The increase is 3.1%. Both budgets are balanced, meaning revenues equal expenses. According to the town assessor the Grand List (property tax base) will grow .81% or \$500 per penny of tax rate, consequently the two budgets

together will require a 3¢ tax rate increase. The annual municipal tax bill for a property assessed at \$175,000 would increase \$52.50.

For FY 16-17 the GF budget would be \$3,502,356, which is 4.5% or \$152,395 greater than the current year budget. The GF tax rate would increase 2.76¢. The GF budget includes the emergency services (police, fire, emergency management and town's payment to its Ambulance Fund). This section is the largest of the three GF sections. Other noteable GF departments are recreation, library, solid waste, and all the offices (or departments) in the municipal building. For instance, the expenses for this newsletter are provided for in the GF.

No additions to or deletions from current GF services are planned. One might say the investments in the recreation properties, especially the softball field, will offer better service. Likewise the police budget includes \$2,970 for a contribution to a regional sex investigation unit that one could say improves the police services.

One minor personnel/staff change is proposed. At the recreation board's request a new part-time (25 hrs./week) seasonal (17 weeks) maintenance worker is included in the proposed budget. The board asked for this new position because the other recreation workers leave work at 3:30; no employee is in the main park after 3:30. Softball, baseball and soccer teams, however, start play between 5:00 and 6:00. The new position will cover that gap.

Significant projects are in the recreation division budget. The budget provides \$19,000 to fix and pave the school parking lot driveway from Websterville Road to the recreation area gate. That should be an one-time expense. \$10,000 is budgeted to replace the buried electric cables to the softball field lights. Thirty-plus years ago cable to the light poles was placed in a ditch without conduit. The proposed project is for conduit and wire from the control panel to each pole. In FY 17-18 the light fixtures may be replaced.

Another significant project expense is a \$12,940 increase in the Cemetery Fund subsidy. \$5,895 of that amount is for sandblasting and painting the historic wrought iron fence on two sides of the Maplewood Cemetery. This \$5,895 would be repeated in FY 17-18 and work done during 2017. The other \$7,045 will be used to reconstruct the main gravel road in the Maplewood Cemetery. That expense should not need to be repeated.

One more noteable project is repairing the softball field backstop, for which \$6,000 was allocated.

The single largest change in a GF expense is an increase of

\$50,000 in the GF's payment to the Ambulance Fund, Barre Town's per capita fee. The second largest change is the aforementioned recreation paving. Third on the list is a decrease of \$16,275 in animal control officer wages because after July 1 Barre Town will not hire-out its ACO to the three other towns. (This produces an equal reduction in reimbursement revenue.) A \$15,280 increase in police straight time wages places fourth on the list of top changes. The Cemetery Fund tax appropriation is fifth, and sixth is a decrease in health insurance premiums (\$10,595).

For FY 16-17 the HF budget would total \$2,747,800, if voters approve. That amount is \$35,580 or 1.31% greater than the current budget. A .24¢ tax rate bump would be needed for that budget.

No staffing changes are planned for the HF budget. One very minor service change is three additional days of street sweeping in late summer (\$1,200). The list of paved road projects (a \$741,095 expense) are shown on page 5.

Other sizeable project expenses are: 1) the town's share of the Peloquin Road culvert replacement (\$45,160); 2) one-half (first year of two) of the town's share of the Bridge Street sidewalk construction (\$12,980); and 3) \$4,315 for drainage work in the Cresent lane and Ridgewood Terrace neighborhoods.

Significant account changes (in order from the biggest) are: 1) -\$16,165 in summer maintenance wages as more of the crew's time is budgeted in other funds and departments, for example recreation and cemetery; 2) +\$9,640 for purchase of salt based on the price paid during 15-16; 3) +\$9,250 in summer maintenance town equipment charges; 4) +\$6,650 for contracted snow plowing because contracts have expired; and 5) -\$4,000 for town's share of Bridge Street sidewalk engineering not needed again.

The ballot lists 17 other funding articles. For the second year Article 5 will ask if voters will approve \$55,000 for the Aldrich Library. (This is in addition to the \$125,000 in the GF budget.) Sixteen not-for-profit agency requests equal \$55,450.

A budget booklet will be available before the election at the following locations: municipal building, Brookside Country Store, Trow Hill Grocery, Morgan's East Barre Market, Quarry Hill Quick Stop, Lawson's Store, Graniteville General Store and Hannaford's. The booklet provides more budget details, the Warnings, and the Budget Tour Booklet.

# **Project Updates**

Bridge Street Sidewalk and Area: This Barre Town project to construct a sidewalk along the north side of Bridge Street between Route 14 and the bridge is still in the preliminary plan phase. Recently it has served as an illustration of how even relatively small-scale efforts to improve transportation facilities can become complex. The planned municipal sidewalk borders private residential property, a planned private development, a state-controlled intersection (Rt. 14), and utilities owned by yet other entities. Three projects affect the Bridge Street sidewalk plan and timeline, but coordination between them should result in benefits to all. Underneath the planned location of sidewalk, Barre City plans to upgrade the water line to the mobile home park on Bridge Street to the east of the bridge. It is in the interests of Town taxpayers that the water line work be complete before the sidewalk is constructed. Fortunately, the City plans to complete the upgrade this spring and sidewalk construction is unlikely before spring 2017.

That brings us to the three projects converging at the intersection, all planned for construction in 2017: the sidewalk, the One Bridge Street private development, and the VTrans Rt. 14/Sterling Hill /Bridge Street intersection improvement project. Recent negotiations between the three parties will likely result in a small portion of the One Bridge Street land being deeded to the town for a left turn lane on Bridge Street; the state constructing the One Bridge Street access to Rt. 14; the state constructing the portion of sidewalk from the intersection to the eastern edge of the One Bridge Street access to Bridge Street; and One Bridge Street constructing the sidewalk portion crossing their access to Bridge Street. The sidewalk project should therefore cost less than the initial budget estimate of \$164,400, funded with federal (80%) and Town of Barre (20%) dollars. Rt. 110/Mill Street/Old 302 Intersection: As described in the February newsletter, the state is in planning stages for improving the intersection of Route 110, Mill Street, Old Route 302, and Bianchi Street in East Barre. VTrans and its consultant engineering firm for the project, VHB, have taken into account input from the January 5 public hearing and have revised the plans so that Bianchi remains a two-way street, instead of changing to a one-way as proposed earlier. To accommodate this, minor adjustments to the Bianchi Street approach to VT 110 are being proposed, as well as some minor vegetation clearing to maximize sight distances for vehicles exiting Bianchi Street. Complete streets components, including pedestrian and bicycle facilities, are being incorporated into the project as possible. Other changes to the intersection, and the timeline for the project, are still as described in the public hearing in the February newsletter. Construction is still planned for 2019. No costs for this project will be borne by the town. For more information contact Harry Hinrichsen, Town Engineer, at 479-2595.

Route 63 Paving: VTrans is planning to pave Rt. 63 (between the Rt. 14 traffic signal and I-89), this summer. The work will be a basic mill, fill (shim) and pave (1.5 inch). The Miller Road/Miller Road Ext./Rt. 63 intersection will not change. The intersection with Rt. 14 will have a slight change: a left turn arrow will be painted on the pavement for traffic pointing east at the Rt. 63/Middle Road light. This left turn will remain unsignalized. This project is being paid for with federal (80%) and state (20%) money.

**Town Forest Logging** - The logger, George deNagy, finished logging the area north of Littlejohn Road. Because of the lack of snow cover and warmer than usual weather town forester Jeff Smith recommended logging on the southside of Littlejohn Road be suspended until the winter of 2016-2017. At its meeting on March 1 the Selectboard voted to extend the contract with deNagy and suspend logging until the fall of 2016. Smith recommends deNagy be allowed to start logging in mid-November, weather and ground conditions permitting. The town received a check for \$1,628 as payment for the wood harvested from the northside of Littlejohn Road

# Tax Grievance Process

The assigning of property values is a science-designed to provide a fair, equitable process - but an imprecise one. This imprecision is addressed by allowing taxpayers to contest the appraisal of the property by the following tax grievance process.



The 2016 Grand List with updated property values will be available at the Town Office in the first week of June. Look for notices of its availability (known as "the lodging of the abstract grand list") on the town website, the newspaper, grocery stores, or post offices. If the Assessor for Barre Town has changed the appraisal of your property, you will receive a notice in the mail. Any taxpayer (not just those whose property appraisal has changed) may dispute their property appraisal through the tax grievance process, which is detailed in state law. A summary of the process is below:

- 1. File a grievance with the Assessor in writing by 14 days from the lodging of the abstract grand list, which will be the same date any notices of change in appraisal are mailed. The Assessor will schedule a time to hear the grievance. The purpose of the Assessor's grievance hearing is to discover any possible errors or omissions in determining the value of a property. The burden of proof and persuasion is on the taxpayer. Upon completing the hearings, the Assessor will notify the taxpayer in writing of his decision. If the taxpayer does not agree with the Assessor's decision...
- Appeal to the Board of Civil Authority (BCA) in writing to the Town Clerk within 14 days from the date that the Assessor mailed the result of his/her grievance hearing, #1 above. The purpose of the BCA Tax grievance hearing is for the BCA to judge whether the property being appealed was assessed fairly when compared to other similar properties in town. The burden of proof and persuasion is on the taxpayer. All parties may introduce any relevant material and evidence (including oral presentation of fact presented under oath) during this hearing whether or not they were submitted previously to the Assessor. After the presentation of evidence and crossexamination, the BCA will appoint an inspection committee of three members to inspect the property and submit written findings to the full BCA within 30 days of the date of the BCA hearing. During the property inspection property owners shall not engage in conversation pertaining to the appeal unless questions are asked by the inspection committee. Within 15 days of the BCA receiving the inspection committees report, the BCA will decide and list reasons for their decision. The Town Clerk certifies the decision, records it in the grand list book, and notifies

- 3. **Appeal to either the state appraiser or superior court** within 30 days of the town clerk's mailing the notice of the decision. More information about this step will be provided by the town clerk when mailing notice of the BCA decision. *If the taxpayer does not agree with the state appraiser or superior court decision...*
- 4. **Appeal to the Vermont Supreme Court.** These appeals are governed by the Vermont Rules of Appellate Procedure.
