

Changes At Wilson Depot



Since 1997, the Central Vermont Solid Waste Management District (District) has operated a trash and recycling depot on 2 acres of Town-owned land designated for possible expansion of public works operations. That era will close at 3:30 p.m. on February 6.

The District had six trash and recycling depots. Except for two, the depot operations lost money, even after the District increased fees last Fall. The District was quickly running out of money. Operating trash and recycling is not a legal mandate on districts (or towns). Inasmuch as the depots were the District's largest expense, the Board of Supervisors believed the best way to correct the District's finances was to close the depots. At its meeting on January 13, 2010, the District Board of Supervisors voted to close its depots at the close of business on February 6.

Many Town residents have become accustomed to the Wilson Depot ritual. Concerned about an increase in illegal roadside dumping and residents' convenience, the Barre Town Selectboard picked up the District's attempt to contract out the Wilson Depot operation. At its meeting on January 26, the Selectboard voted to give licensed trash hauler John Sevigny the right to set up for waste collection business at the Wilson Depot on Tuesday - February 9, Saturday - February 13, and Tuesday - February 16. Mr. Sevigny will charge \$4 per typical 30 gallon trash bag and recycling will be free. Due to the stop-gap, short-term service, Mr. Sevigny's service basically will be limited to trash and the District's required recyclables.

Also at the January 26th meeting, the Selectboard reviewed an outline for a request for proposals (RFP) and authorized staff to release it to possible depot operators. Proposals were due from waste haulers on Friday, February 5. The Selectboard plans to award a contract at its meeting on February 9. The waste hauler selected will operate the Wilson Depot from February 20 to October 30, 2010. The RFP requires the new operator to be open on Tuesdays and Saturdays from 8:00 a.m.-3:30 p.m. The operator must collect household trash and the recyclables mandated by the District Board of Supervisors. However, the bidders may propose additional hours and additional services. The cost of these services is not known yet.

During the 8-month contract, the Town will consider long-term options. Is it necessary for the Town to be involved in solid waste collection? If the Town is involved, what level of service should the Town provide? What is the best method for the Town to make that service available?

The changes at the Wilson Depot do not affect the public's options for household trash and recycling collection. Residents can buy home pick-up service; they can take their trash and recycling to any of the several licensed roadside haulers; or residents can use the Wilson Depot or a privately-owned depot in Montpelier. The changes at Wilson should not affect the Town's bulk collection service. The District will continue offering, as required by State law, household hazardous waste collections.

Operation details will be disseminated by the selected contractor. The Town will assist by posting information on its web site homepage (<u>www.barretown.org</u>).

Budget Work Underway

Review of the Town Manager's proposed 2010-2011 municipal budgets started January 26. The Budget Committee, consisting of the five Selectboard members and five citizens, will meet every Tuesday night until the end of March to study every one of the 9 fund budgets.

The five citizens on the Budget Committee were appointed on January 5. At the Selectboard meeting that night, the Town Clerk-Treasurer announced Tracy Delude was her appointment. The Selectboard voted to appoint first-timer Rolland Tessier and Jon VanGuilder who had serviced once before. Those three people talked that night and appointed Paul Malone and Val Vallerand to complete the Committee. Mrs. Vallerand is a veteran committee member. This is Mr. Malone's first year on the Budget Committee, but he has served the Town many years on the Zoning Board and now on the Development Review Board.

In December, the Selectboard on the record stated the Budget Committee will have final say about the fiscal year 2011 budgets. What the Committee decides is final for all budgets, except the General Fund and Highway Fund budgets that are presented for voter approval.

Budget review sessions are held from 6:30 to 8:00 p.m. every Tuesday before the Selectboard meeting starts. The public is welcome to attend Budget Committee sessions. The topic for each budget review session is listed on the Selectboard's meeting agenda, which can be read on www.barretown.org. The public may inspect a copy of the proposed budgets at the Town Manager's Office, M-F, 8:00 a.m.-4:30 p.m.

Time To License Your Dog(s)



Vermont law (20 VSA, Sec. 3541-3591, 3801-3813) requires all dogs and wolf/hybrids be licensed annually in the Town in which the pet resides.

To license your pet, the Town Clerk's

Office must have a current rabies certificate on file. The fee to license a dog is \$9 for a spayed or neutered animal and \$13 for an animal that is not fixed. Deadline to license your dog(s) is April 1, 2010. If your pet is found to be unlicensed after April 1, you can be fined \$35.00.

The Town Clerk's Office has just mailed the 2010 dog license renewal forms to those dog owners who have a current rabies certificate on file. For those rabies vaccination certificates which have expired or will expire before the April 1st deadline, a postcard reminder was sent. Please remember, when providing the Town Clerk's Office with a current rabies certificate by mail be sure to include the license fee.

If you have animal complaints, you can contact the Barre Town Police Department. A copy of the Animal Control Ordinance, which includes leash restrictions, can be obtained from the Town Clerk's Office at 479-9391 or on the website at www.barretown.org (click on the button "Charter, Ordinances & Policies").

Be a responsible pet owner! Make sure your pet is licensed, has a current rabies vaccination, and the current year license tag is affixed to your pet's collar.

HS-122 Homestead Declarations Due April 15

A homestead declaration must be filed each year by Vermont resident homeowners who own and occupy property as their principal residence on April 1st of each year.



A homestead is described as the principal dwelling and the entire parcel of land surrounding the dwelling less any portion of the buildings used for business. The declaration must be filed even if you are not required to file an income tax return. Homesteads can be filed online at http://tax.vermont.gov any time after the first of each year and should be completed as early as possible. Homesteads can be filed separately from your income tax return. No extension of time to file is available, and an extension of time to file an income tax return does NOT apply to the Form HS-122.

Filings after April 15 will be accepted with a penalty of 1% until September 1, but after September 1 the property will not qualify for homestead status and the non-residential tax rate will be applied. Your property will be set in the Grand List as non-residential until you file your homestead declaration. An example of the difference in tax rate bills for 2009 showing a difference of .4908/100 on the tax rate between residential and non-residential is as follows:

\$100,000 home x non-residential rate of 2.4797 = \$2,479.70\$100,000 home x residential rate of 1.9889 = \$1,988.90Difference = \$\$490.80

If you buy a home on or before April 1, 2010, you are responsible for filing the homestead declaration. If you buy a home after April 1, the seller is responsible for filing a homestead declaration, if applicable. Ask about it at the real estate closing.

Please feel free to call the Assessor's Office if you need assistance in filing your homestead declaration for 2010.

Annual Egg Hunt



A Barre tradition will be continued this April. The Barre City and the Barre Town recreation departments will hold the 23rd Annual Egg Hunt on April 3. The event starts at 10:00 a.m. on the dot; don't be late or you'll miss the action. The egg hunt is held rain or shine, so dress appropriately.

The search for chocolate and plastic eggs (containing prizes!) is held near Barre City's Playground 2000. Parking is available at the Barre City Elementary & Middle School; carpooling is suggested.

Children are grouped by age (3-4 year olds; 5-7 year olds; and 8-10 year olds). Children need to bring a bag or basket.

There is no fee to participate, but families are asked to bring non-perishable food items that will be collected for the Vermont Foodbank. For safety reasons, leave pets at home.

March Town Meeting Day

Barre Town has two separate Town
Meeting Days. The school holds election
of officers and vote on special articles on
the traditional Town Meeting Day (1st
Tuesday in March - March 2, 2010), while
municipal elections, budgets, and other
ballot questions are presented at a date prescribed by Town
Charter (2nd Tuesday in May - May 11, 2010).

The ballot can be divided into three topic areas: elections, budgets, and issues for voter consideration. Notable mention is given to articles within the aforementioned topic areas. First, starting with school elections, William Kirkland, Laura Moore, and John (Jay) Paterson are up for re-election to Barre Town Middle & Elementary School's school board. Joel Garbacik is seeking election to the Spaulding Union High School board. Second, the voters are asked to approve an operating budget for BTMES of \$10,202,140 and for SUHS \$11,792,453. Third, notable issues for consideration include: election of a School Treasurer (currently the Town Treasurer fills this position), authorization of funds for long-term roof repair, and authorization to spend up to \$183,000 to renovate the BTMES kitchen.

In addition, there will be a food drive to benefit the Vermont Foodbank. Local resident Jean Merrill has incited a friendly competition between Barre Town, Barre City, Montpelier, and Berlin to see who can collect the most food per registered voter by pound. Early-ballot voters can participate by dropping food donations at the Town Clerk's Office.

Petitions - Info To Know!

Want to run for an elected office but don't know how? Do you have a question to put on the ballot but don't know what you need to do? The answer to both questions is through a petition process.

Barre Town and our School Districts are governed by Vermont Statute (law) and a Charter. What one does not cover, the other does. To place a question on the ballot, there are two options: by Board order (Warning) or by petition. Items like the operating budgets, permission to purchase land, setting tax due dates, using reserve funds, etc. are placed on a ballot by Warning from the governing body (Selectboard or School Board). Other items (like running for elected office and a not-for-profit agency funding request) require a petition. Below are the petition requirements if you want to run for an elected office. Note the difference between the number of required signatures on a School petition versus a Town petition ... one is governed by State law and the other by Charter. For the same reason, there is also a difference in the deadline to submit a petition.

The petition for a question (excluding Board-warned questions and elected office) must, by Town Charter, contain at least 10% (560) of registered voter signatures before it can be placed on the ballot. The not-for-profit questions which appear on the Annual Town Meeting ballot in May are examples of this type of petition.

Petition forms and Consent of Candidate forms are available from the Town Clerk's Office. A petition usually consists of several pages. Each page of a valid petition will contain, at a minimum, the question as it is to appear on the ballot, and an area beneath the question to allow for voter information (name, signature, and place of residence). Each election has a deadline for petition. Petition deadlines have already passed for the School Election on March 2. However, the Annual Barre Town Election (for municipal issues) will be held on May 11. If you would like to run for an elected Town Office (Selectboard, Auditor, Constable, or Moderator), the deadline to submit your petition will be Monday, March 29, 5:00 p.m. For more information on the election process, contact the Town Clerk at 479-9391 or email dkelty@barretown.org.

DPW Pre-Wetting Road Salt

The Public Works Department is making an effort to use winter road salt more effectively. This winter, the crew has set up a 100 gal. calcium chloride tank on the tailgate of one dump truck. The tank is connected to a spray nozzle mounted just above the spinner behind the left corner of the truck cab. As the salt drops onto the spinner, it is dosed by the calcium spray at the rate of 1 gallon per minute. The tank assembly cost approximately \$2,100 and took \$250 of labor to complete the installation.

Pre-wetting salt has two benefits. The pre-wet salt stays in the center of the road better than un-wet salt. According to the <u>Vermont Local Roads News</u> (December 2008), 32% more salt stays in the center of the road when pre-wet. Thirty percent (30%) of un-wet salt will bounce off the road, but only 4% of pre-wet salt leaves the road. Highway maintenance workers want the salt in the center of the road so it spreads over both lanes. It is suggested salt distribution rates can be lowered from 500 pounds per road mile to 350 pounds.

The second benefit is the chemistry of calcium chloride. Salt is effective down to 15°F. Calcium chloride lowers the activation temperature to 5°F (pavement temperature).

The DPW is experimenting with the pre-wet salt this winter (and maybe next) before deciding if it saves salt and money and is more effective than plain road salt.

Project Updates

■ Semprebon Bequest & Bike Path: Last summer, the Town and public learned that Charles Semprebon, a Town resident and a cycling enthusiast, bequeathed the Town of Barre and the City of Barre half-amillion dollars each. The money must be used for construction of a bike path that connects the Town's Millstone Hill West path to Barre City. The Selectboard quickly appointed a committee consisting of Bob Murphy, Jeff Tucker, Linda Rogers, Lionel Cyr, and Jean Coello. The committee has met frequently since late summer, including several meetings with the City committee. When the Selectboard created the committee, they gave it two assignments: (1) the Semprebon connector path and (2) completion of the East Barre path. The Semprebon money, however, can be used only for the Barre City connector path.

In October, the committee went on a field walk to acquaint itself with the East Barre path and to scope out possible routes from Websterville to Barre City. Two general routes were identified; both start where the snowmobile trail intersects with the Millstone Hill West path and have the South Barre bike path as their destination.

In December, the committee received Selectboard approval to issue an RFP for a preliminary engineering study. The Semprebon Estate approved using money from the bequest for the study. Just before New Year's, the estate issued \$500,000 checks to both the Town and the City. Property owners in the vicinity of both routes have been invited to a meeting on February 15. The RFP will be released after the property owners' meeting.

■ Wilson Industrial Park - SB Electronics: After November, the Department of Public Works finished laying the electric, phone, and cable TV conduits to Bolster Road. All 7 concrete electrical vaults were installed. Green Mountain Power started work towards extending 3-phase power down Bolster Road. In the Spring, GMP will return and pull its electric cables through the 2,900 feet of conduit laid by the DPW. Also this Spring, the DPW must construct the gravel base of the industrial park road from Bolster Road to SBE's driveway. (The park road will be gated at Bolster Road.) The Town will contract for road paving and stormwater retention pond construction.

The Town also has business to conclude with SB Electronics. The real estate sale has not closed yet, but is expected very soon. The Town received a \$1 million Community Development Block Grant of which \$984,000 is to be loaned to SBE. The loan documents will be completed and signed soon. The Town is making plans,

with Barre Area Development, to re-use the SBE loan money for a business revolving loan fund that would serve Barre Town and Barre City. Groundbreaking pictures in the next newsletter?

- Bridge Street bridge: The new bridge project requires relocation of a sewer line and adjustments to several manholes. The Town is responsible for engineering changes to its sewer utility. The State, however, will incorporate the sewer work into the bridge construction contract. The Agency of Transportation (AOT) required an agreement between the Town and an engineering firm. The Town chose its consulting engineer for sewer matters Forcier & Aldrich. F&A's engineering services contract was sent to the AOT, which approved the agreement and returned a separate agreement between the State and Town. That agreement was approved by the Selectboard in January. F&A is working on plans for the sewer line and manholes. Construction is expected in 2012.
- East Barre Sidewalk: The sidewalk project needs three approvals before the project manager can officially call on property owners and acquire right-of-way deeds. The approvals must be issued sequentially; thus there can be no official action until the first approval (a check-off in the environmental assessment process) is issued, then the second, and then the third. In the meantime, the project team has prepared right-of-way plans (drawings) and has drafted right-of-way deeds to be ready for action when AOT gives the nod. Construction is still planned for 2010, but when in 2010 depends largely on how soon AOT can perform its reviews and give authorization to proceed.

The grant-funded project will build a curbed sidewalk from the fire station driveway to Websterville Road, and then along Websterville Road to the post office. A very short section of sidewalk will be built in front of the library with a crosswalk to the main sidewalk.
